#### **Investment Objective**

Capital Gearing Trust's (CGT) goal is to preserve and grow shareholders' wealth over time. CGT seeks long-term absolute returns through a global portfolio of equities, bonds, and commodities, using a low-cost approach without the use of gearing or short selling. Since 2015, CGT's discount control policy ensures the share price closely tracks the Net Asset Value (NAV) per share by issuing or purchasing shares as needed.

#### **Manager Comment**

Capital Gearing Trust has continued to maintain its defensive stance in February, with a focus on inflation protection. The portfolio has returned 0.3% over the month, and 5.8% year-on-year. Key allocations are 32% to risk assets (including gold), 36% to index-linked bonds, and 32% to dry powder (cash, treasury bills and corporate credit). Risk assets increased over the month with additions to investment trust holdings. Index linked bonds were the top contributor to performance over the month.
